- WHO:** Piedmont Middle School 7th & 8th grade girls are eligible to try out for the traveling teams.
- WHAT:** There will be two traveling teams in each grade. Competition will be against other schools. **Players will be selected for traveling teams based upon skill evaluation. Traveling team parents will be required to drive to games.** The team parent for each team will make these assignments once the game schedules are complete. The commitment for this program is Monday through Thursday.
- WHEN:** The season will commence in November and conclude in January. Practices will be held after school at either 3:15 - 4:45 pm or 4:45 - 6:00 pm, and on Sunday evenings 5:00 - 6:30pm or 6:30- 8:00 pm. Games are played after school.
- FEE:** \$260.00 non-refundable participation fee and a \$30.00 refundable uniform deposit. **Please issue two separate checks,** made payable to the Piedmont Recreation Department. Scholarships are available.
- SIGN-UPS:** Please bring in or mail your registration form and the Behavior Agreement to the Piedmont Recreation Department, 358 Hillside Avenue no later than **October 15, 2009.**
- BEHAVIOR CODE:** Every player and a parent must sign a Behavior Code Agreement. Registration will **NOT** be accepted unless a signed agreement is included.

Mandatory evaluations will be held on **Tuesday October 20** and **Wednesday October 21.** All players must attend both sessions. Additional sessions may be added if necessary.
